PRIVACY POLICY

1. Purpose and Scope

UAB Oberfed (also referred to as "we," "us," or "Company"), company registration number 306974230, having its registered office at Taikos pr. 15B, Visaginas, Lithuania, is committed to protecting and respecting your privacy.

3. How We Collect Your Personal Data

We collect information you provide directly to us when you:

- 4. Use our Services.

We may also receive your personal data from third parties, such as:

- Business partners, subcontractors, service providers, and merchants.
- Banks or other financial institutions during payment operations.
- Other entities we collaborate with.

4. Direct Marketing

If you are our existing client (i.e., you already use our Services), we may use your email address for direct marketing purposes regarding products or services similar to those you use, provided you do not object to such use.

5. How We Share Your Personal Data

We may disclose your personal data to the following categories of recipients:

- 1. Public authorities, institutions, organizations, courts, and other third parties as required by law.
- 2. Third-party service providers (e.g., legal, financial, cloud, and hosting services), who process data according to our instructions.
- 3. Affiliate companies belonging to the same group.
- 4. Third parties involved in a business sale transaction or legal due diligence.
- 5. Other persons with your consent.

6. International Data Transfers

If your personal data is transferred outside the European Economic Area (EEA), we ensure it is protected according to GDPR requirements through:

- Adequacy decisions by the European Commission.
- Standard contractual clauses (SCCs).
- Special permissions from supervisory authorities.

7. How Long We Keep Your Personal Data

We retain your personal data for as long as needed to fulfill the purposes for which it was collected, or as required by applicable laws. Typically:

- Data related to contracts is stored for 10 years after the contractual relationship ends.
- Data without a contract is retained for up to 6 months.
- Longer retention may apply for legal claims, disputes, or as required by law.

8. Your Rights

You have the following rights:

- **Right to be informed**: Transparent information about data processing.
- Right to access: Request a copy of your personal data.
- Right to rectification: Correct inaccurate or incomplete data.
- Right to data portability: Transfer your data to another organization.
- **Right to be forgotten**: Request deletion of data when it's no longer necessary.
- **Right to restrict processing**: Limit data processing under certain conditions.
- Right to object: Object to certain types of processing, including marketing.
- **Right to lodge a complaint**: File a complaint with the State Data Protection Inspectorate of Lithuania.
- Right to withdraw consent: Withdraw consent for processing based on it.
